### **Detailed Overview**

The Psychologist is in charge of psychological services for the Early Psychosis Intervention Program and is responsible for the provision of a full range of psychology services within a multidisciplinary team that provides mental health services to the community. Provides expertise including assessment, diagnosis, intervention and evaluation in conjunction with team members and existing community care networks. This position may be required to work at more than one site within an assigned geographic location.

  - Participates in the short and long-term planning for the assigned program through methods such as evaluating the effectiveness of the treatment within the program, identifying opportunities for change and formulating recommendations for quality improvement to ensure optimal outcomes are met.
  - Participates as a member of the multidisciplinary treatment team by participating in team meetings, participating in the decision making process as it relates to team functioning and provision of service, and attending clinical/case conferences for client reviews, admissions and discharges.
  - Produces and maintains confidential client clinical records in accordance with established standards and procedures; writes timely and accurate reports of relevant observations and evaluations of care to ensure continuity of communication and full client documentation.
  - Participates and promotes educational programs on therapeutic and assessment techniques.
  - Initiates and carries out program evaluation in consultation with Manager or assigned program Coordinator by suggesting hypotheses, identifying relevant variables, formulating a research design and carrying it out.
  - Performs other related duties as assigned.
